



Dog Walking Contract

This Dog Walking Contract ('Contract') is made effective as of Date: _____, by and between Full Name: _____ and Full Name: Jordan Flynn on behalf of Company: Press Paws. In this Contract, the party who is contracting to receive the services shall be referred to as 'Owner' and the party who will be providing the services shall be referred to as 'Dog Walker.'

Whereas the Owner wishes to engage the Dog Walker and the Dog Walker agrees to undertake the services under the terms and provisions defined in this Contract as well as the Client Information Form (Exhibit A) and the Veterinary Instructions and Release Form (Exhibit B) which shall both become part of this Contract. Any reference to Dogs in this Contract refers to the Dogs specified on the Client Information Form.

Dog Walker will provide the services stated herein in a reliable, caring, and trustworthy manner. In consideration of these services and as an express condition thereof, Owner expressly waives and relinquishes any and all claims against Dog Walker except those arising from gross negligence or willful misconduct on the part of Dog Walker.

DESCRIPTION OF SERVICES

Beginning on Date: _____, the Dog Walker will provide the following services (collectively, the 'Services')

SERVICES: Dog Walking

PAYMENT FOR SERVICES: Dog Walker shall be paid the amount of \$ _____ per week. If Owner will not require services on a particular day or days, Owner shall telephone Dog Walker a minimum of 24 hours in advance of the Service not to be rendered; no adjustment to fees will be made for the week, unless no services at all are rendered that week. Fees for additional visits will apply and shall be paid promptly.

If a medical emergency arises for Dog(s), Dog Walker will make every effort to contact the Owner but if time is of the essence, Owner authorizes Dog Walker to seek medical services at the closest Veterinary Hospital. Owner agrees to reimburse Dog Walker for all services rendered by Veterinarian in accordance with Owner's wishes as stated and signed in the "Veterinary Instructions and Release Form."

Owner represents and warrants that Dog(s) are currently vaccinated in accordance with all local and state laws and regulations. Owner agrees to indemnify, defend and hold harmless Dog Walker from all liabilities, claims and expenses, including reasonable attorney's fees, that arise from or relate to Dog's behavior, including without limitation property damage, personal injury, or death caused by Dogs. Dog Walker reserves the right to terminate this contract at any time before or during its term if Dog Walker, in their sole discretion, determines that Owner's pet(s) pose a danger to the health and/or safety of Dog Walker. If this occurs, Dog Walker will notify the Owner immediately of the issues.

In the event of inclement weather or natural disaster, Dog Walker will use their best judgment in caring for Owner's Dog(s) and home but cannot be held responsible for any damage to home or injury to dogs arising from such. If an emergency arises (such as a pipe rupture, flooding, earthquake, fire, break in, power failure, etc.), Dog Walker will make every effort to contact Owner and follow their instructions. If Owner cannot be reached or immediate

action is necessary, Owner authorizes Dog Walker to make any repairs deemed necessary by the Dog Walker. In the event of such an emergency, Owner shall immediately reimburse Dog Walker for expenses incurred, plus any additional fees or expenses for attending to such an emergency. Owner agrees to defend, indemnify and hold harmless Dog Walker from all liabilities, claims and expenses, including reasonable attorney's fees, which arise from or relate to such decisions.

Owner is responsible for providing keys to access their home or building. Owner is to notify Dog Walker if anyone else has keys or access to Owner's property other than Dog Walker; Dog Walker cannot be held liable for damage done to home and pet(s) by others with such access. In addition, Dog Walker shall not be held liable for damage done by dogs to either the interior or exterior of home when Dog Walker is not there. Dog Walker is not liable for dogs that are left outside or may escape when Dog Walker is not in attendance.

Either party may terminate this Contract at any time for any reason or no reason by providing the other party with notice of such termination. This Contract constitutes the entire agreement between the parties in connection with the subject matter hereof and supersedes all prior and contemporaneous agreements, understandings, negotiations and discussions between the parties, whether oral or written. The validity, construction and performance of this Contract shall be governed by and construed in accordance with the substantive law of the Commonwealth of North Carolina, without regard to conflicts of law provisions. Should any section, provision, or portion of the Contract be held to be invalid, illegal, void or unenforceable, then such section, provision or portion shall be deleted from this contract. The remainder of this contract shall continue in full force and effect to the maximum extent permissible.
